Deputy Manager Procurement briefed the prospective bidders regarding contents of the bid document as follows:

 a) Instructions to bidders Technical Specifications/TORs
 Bid Form, Special Stipulations and Price Schedule Templates of required forms
 Draft Contract

b) It is mandatory to submit the bidding forms as per the formats provided in the bidding document.

c) Bidders must meet the Eligible Bidder / Criteria (Mandatory Criteria).

- d) Joint Ventures / Consortium & Sub Contracting between shortlisted applicants at this stage is not allowed.
- e) All the pages of bidding documents will be signed and stamped by Authorized Representative. Letter of Authorization will be also be the part of the technical bid.
- f) Bid Security is 2% of the estimated price and in the form as mentioned in the bidding document.
- g) Performance security will be 5% of the contract/ purchase order amount and in the form as mentioned in the bidding document.
- h) Single Stage Two Envelope bidding procedure shall be followed.
- i) Management welcomed the questions from the potential bidders with the assumption that they have gone through the bidding document. Queries and replies is as follows:
