SUMMARY:

THIS DOCUMENT CONTAINS THE COMPREHENSIVE DETAILS OF THE RESOURCES DEPLOYED FOR CONTAINERS COLLECTION IN 2ND SHIFT IN THE AREA UNDER THE JURISDICTION OF WORKSHOP-3 (VALENCIA).

1. Introduction:

Solid Waste is generated in the communities throughout the day, so arrangements should be made to cater the generated load in the earliest possible time.

Container based collection during second shift must be planned and executed so, to efficiently collect MSW from main roads & commercial markets.

2. General SOPs for container collection during 2nd shift:

Depending upon the need C-7, C-13 compactors and mini-dumpers are distributed in all the zones for the collection of waste. The general SOPs for the operation is described as under:
